**Government Order No.1072–GAD of 2015,
Dated:07.08.2015.**

As recommended by the Jammu and Kashmir Public Service Commission, sanction is hereby accorded to the temporary appointment of 96 candidates, as per the details in Annexure – I to this order, to the Junior Scale of the Jammu and Kashmir Administrative Service, J&K Accounts (Gazetted) Service and J&K Police (Gazetted) Service, against the posts, under the direct recruitment quota, in the Pay Band of ₹ 9300-34,800 with Grade Pay of ₹ 4800, with immediate effect.

The candidates hailing from Kashmir and Jammu Divisions, allotted to the Junior Scale of Jammu and Kashmir Administrative Service, shall report in the J&K Institute of Management, Public Administration and Rural Development (J&K IMPA & RD) Srinagar/ Jammu, respectively. However, the candidates hailing from Ladakh region may join, as per their convenience, either at J&K IMPA & RD Srinagar or J&K IMPA & RD Jammu.

The candidates allotted to the J&K Police (Gazetted) Service and the J&K Accounts (Gazetted) Service shall report to the Director General of Police, J&K and the Director General, Accounts and Treasuries, J&K, respectively.

The candidates shall be allowed to join only on production of the following certificates (in original):-

- (i) Qualification Certificate
- (ii) Date of Birth Certificate
- (iii) Permanent Resident Certificate
- (iv) Relevant Category Certificate
- (v) Any other certificate required under rules

The candidates who fail to join within a period of twenty one days from the date of issuance of this order shall forfeit their right to the appointment, which shall be cancelled forthwith.

The salary of the appointees shall be drawn and disbursed to them only on receipt of the verification report from the verifying agency, viz; CID and production of an affidavit on the prescribed format forming Annexure – II to this order.

The appointees shall be on probation for a period of two years during which they shall undergo such training and pass such Departmental Examination as prescribed under rules.

The names in the appointment order shall not be construed to be in order of their seniority, which shall be determined by their respective cadre controlling departments i.e. General Administration Department, Finance Department and the Home Department, strictly in terms of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.

The appointment and allocation of the candidates to the respective services shall be subject to the outcome of writ petition(s), if any, pending adjudication before any competent court(s).
