**Subject:- Republic Day Celebrations, 2017-Attendance thereof.**


**Circular No. 03 –GAD of 2017**

The main function of the Republic Day is being held at Maulana Azad Stadium, Jammu, where the Hon'ble Governor will take the salute.

During the Republic Day Celebration 2016, vide circular No.04-GAD of 2016, dated 20.01.2016, all the Officers/Officials of the State Government and Public Sector Undertakings (PSUs) stationed at Jammu were directed to attend the function as a part of their official duty. Besides, all Heads of the Departments and Chief Executives of the Public Sector Undertakings (PSUs) were directed to ensure their own participation and also of the employees subordinate to them in the function. However, despite clear instructions of the General Administration Department, many of the Officials/Officers of the State Government and Public Sector Undertakings, have not attended the function, which had been viewed seriously by the Government and the concerned were warned to remain cautious on this account in the future.

Now, it is impressed upon all the Officers/Officials of the State Government and Public Sector Undertakings (PSUs) stationed at Jammu to **attend the Republic Day Function 2017, at M.A. Stadium, Jammu**, as a part of their official duty and failure to attend the function will be construed as dereliction of the duty and disobedience of the Government instructions. The disciplinary action as admissible under rules shall be initiated against those **who fail to attend the function.**
