As per Rule 4 A(1), Rule 5(1), Rule 9(1) read with Schedule 2 of the AIS (PAR) Rules, 2007, as amended, the following time lines have been prescribed for self appraisal, reporting, reviewing and acceptance of PAR in respect of All India Service officers:-

Activity	Cut off dates
Self appraisal for current year	31 st May
Appraisal by Reporting Authority	31 st July
Appraisal by Reviewing Authority	30 th September
Appraisal by Accepting Authority	31 st December

In view of specific timelines in the rules, all the All India Service Officers posted in the Union territory of Jammu and Kashmir are enjoined upon to submit their self appraisal for the year 2021-22 by or before 31st May, 2022 failing which their PAR for the year 2021-22 shall be forced forwarded to the concerned Reporting Authorities.
