- iii. The appointee shall further be allowed to join only on production of the following certificates in original:
 - a) Academic Qualification certificates
 - b) Technical Qualification Certificates
 - c) Matriculation/date of birth certificate
 - d) Health certificate issued by competent authority
 - e) Certificates from the concerned District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
 - f) Migration Certificate of being a Kashmiri Migrant duly issued by Relief and Rehabilitation Commissioner, Migrants.
 - g) Relevant category certificate(s) if any.
- iv. The appointment of these candidates shall be further subject to the following:
 - a. Each appointee shall submit an affidavit at the time of joining undertaking therein that in case of any adverse report about his/her Character and Antecedents is received from the office of the IGP, CID, J&K, to whom a reference shall be made by the Managing Director, KPDCL, Sninagar, the appointee(s) shall have no right to claim his/her appointment as Draftsman (Electrical) in the Power Development Department and his appointment as such shall be deemed to have been cancelled ab-initio.
 - Verification/genuineness of the qualification/technical/reserved category certificates and other certificates from the concerned issuing authorities.
- v. The documents/certificates of appointees may be verified and if on verification, any document of any appointee is found fake/fictitious, the Managing Director, KPDCL, Srinagar may convey the status of the same to the Administrative Department, so that necessary action is taken accordingly.
- vi. The salary of the appointees may be drawn and disbursed only after satisfactory report in respect of iv (a & b) above are received in their favour.
- vii. The appointment of these candidates shall be governed by the "New Pension Scheme" as per SRO 400 dated 24.12.2009 and the appointees shall be on probation for a period of 2 years.
- viii. The inter-se-seniority of these appointees shall be determined in accordance with the merit acquired during selection and in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1959 and other relevant rules.
- ix. In case any appointee migrates from the Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his/her migration.
- x. If the appointee (s) fail to join within a period of 21 (twenty one) days from the date of issuance of this order they shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
