It is hereby ordered that:

- all Government Offices/PSUs/Institutions/Corporations across the Union territory of Jammu and Kashmir shall switch over to Biometric System (Aadhar or Finger Print based) of marking attendance with immediate effect and all employees shall necessarily mark their attendance both at arrival and departure as per the notified office hours of various offices.
- all Administrative Secretaries/HoDs/ Managing Directors of PSUs/Institution/Corporations shall ensure installation of Biometric Attendance Systems/Equipments in all offices/institutions under their administrative control by or before 15th of June, 2022.
- iii) concerned DDOs shall draw the salaries of employees working in various departments of Civil Secretariat only on the basis of satisfactory biometric attendance w.e.f 1st July, 2022.
- iv) salaries of employees working in subordinate offices/PSUs/ Corporations/ Institutions etc. shall be drawn on the basis of satisfactory biometric attendance w.e.f 1st August, 2022 only by their DDOs.
