2. COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned corporation/organization;
3. No arrears on account of pay or COLA/DA shall be paid in favour of these officials by the Government;
4. The salary shall be released in favour of these officials from the date they join duties;
5. They shall retain lien in their parent Corporation/Organization;
6. These officials are still on the rolls of their parent Corporation/Organizations and have not opted for the Golden Handshake Scheme which shall be certified by the concerned Organization;
7. The above arrangement shall be reversible without any notice; and
8. The posts vacated by these officials in their respective Corporations/Organizations shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.

Further, the salary in respect of official at S.No. 2, 3, 12 & 13 shall continue to be drawn from the J&K Legislative Assembly on the production of a Monthly Attendance Certificate.

All the officials shall be deemed to have been relieved.
