On the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the appointment of Mr. Waseem Raja S/o Bashir Ahmad Magray R/o Badipora Chadoora Budgam as Junior Stenographer under RBA Category in the J&K Secretariat (Subordinate) Service in the Pay Level-6B (35600-112800), with immediate effect.

The appointee shall report to the Additional Secretary to the Government, General Administration Department (Establishment), within a period of twenty one (21) days from the date of issuance of this order failing which, he shall forego his right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further Notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- 
- i. Academic/Technical Qualification Certificates.
 - ii. Matriculation/Date of Birth Certificate.
 - iii. Health Certificate issued by the Chief Medical Officer.
 - iv. Domicile Certificate issued by the Competent Authority.
 - v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
 - vi. Valid relevant Category Certificate.

The appointment of the above candidate shall further be subject to the following conditions:

- a. The appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, his

Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found fake/forged his appointment as Junior Stenographer in the J&K Secretariat (Subordinate) Service shall be deemed to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him.

- b. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth and Relevant Category Certificates are received from the concerned authorities/agency.
- c. The appointee shall be on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- e. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.


