Subject: Assured Career Progression Scheme – Constitution of a Sub-Committee thereof.

Government Order No.1339–JK(GAD) of 2024,
Dated:09.07.2024.

Sanction is hereby accorded to the constitution of a sub-committee comprising of the following officers to examine the issue related to the Assured Career Progression (ACP)/Time Bound Promotion (TBP) Scheme with regard to the different departments except Jammu and Kashmir Administrative Service and J&K Police (G) Service:

1. Mr. Shaleen Kabra, IAS, Financial Commissioner (Additional Chief Secretary), Jal Shakti Department.
2. Mr. Santosh D. Vaidya, IAS, Principal Secretary to the Government, Finance Department.
3. Mr. Sanjeev Verma, IAS, Commissioner/Secretary to the Government, General Administration Department.
4. Mr. Achal Sethi, Secretary to the Government, Department of Law, Justice and Parliamentary Affairs.
5. Administrative Secretary of the department concerned.

The sub-committee, while examining the issue, shall consider (but not limited to) the following aspects:

- (i) A comprehensive view of the scheme.
- (ii) Identification of service-specific solutions by analyzing the pyramid structure, recruitment patterns, and recruitment rules.
- (iii) Evaluation of the service specific need for cadre restructuring or scheme like Assured Career Progression.

- (iv) Justification of whether the Assured Career Progression Scheme is necessary for a particular service.
- (v) Consideration of any harsh conditions imposed on members of a particular service that are beyond their control.
- (vi) Conditions to be imposed for extending the Non-functional scheme in the particular service.
- (vii) Development of a justifiable solution that does not become endless.
- (viii) Establishment of basic criteria for an equitable solution.

The sub-committee shall submit a detailed report thereof, for consideration by the Establishment-cum-Selection Committee within a month.
